### Introduction

Welcome to Bloch.ai ("we," "our," or "us"). We understand that your privacy is of utmost importance, and we are committed to protecting any personal information you share with us. Our website is hosted on the Wix.com platform, which provides us with the online infrastructure to deliver our services to you. This Privacy Policy outlines our practices regarding information collection, use, and disclosure.

### Information Collection and Use

When you visit bloch.ai, we collect various types of information to provide you with the best possible service experience. This includes information you actively provide us, such as your name, email address, and payment details when making purchases or creating an account. We also automatically collect technical data about your interactions with our website, including your IP address, browser information, and how you navigate through our pages. This helps us understand how visitors use our site and allows us to improve our services continuously.

The Wix.com platform stores your data securely on their servers, protected by firewalls and following industry-standard security protocols. For payment processing, we utilise Wix.com's payment gateways, which adhere to the strict standards set by PCI-DSS, managed by the PCI Security Standards Council. This ensures that your payment information is handled with the highest level of security, backed by major credit card providers including Visa, MasterCard, American Express, and Discover.

We may share your personal data with trusted third-party service providers who assist us in operating our business, such as, but not limited to, analytics providers, marketing platforms, or payment processors. These third parties are contractually obligated to handle your data securely and use it solely for the purposes specified by us. We do not sell or rent your personal data to any third parties.

### **Data Retention**

We retain your personal data only for as long as necessary to fulfil the purposes outlined in this Privacy Policy, our website, any separate contract or agreement with you, or as required by law. For example, we will retain account information for the duration of your relationship with us and for a period thereafter to comply with legal obligations, resolve disputes, or enforce our agreements. Once this period expires, your data will be securely deleted or anonymised.

#### Cookies and Technical Information

Our website employs several essential cookies to ensure optimal functionality and security. These include security-focused cookies such as XSRF-TOKEN for fraud detection and TS\* for attack detection, both of which operate only during your browsing session. For identification and performance purposes, we use svSession cookies that remain active for six months and SSR-caching cookies that last 24 hours. System effectiveness is measured through bSession cookies with a 24-hour duration.



We also utilise longer-term cookies such as fedops.logger.sessionId, which helps us track and address technical issues for up to 12 months, and \_wixAB3|\* cookies that support site experiments for six months. To protect our API services, we implement server-session-bind and client-session-bind cookies that last for your browsing session. Each of these cookies plays a vital role in maintaining site security, performance, and functionality.
